

# ANNEXURE TO THE ROTATIONAL SHIFT SYSTEM FRAMEWORK

Parties hereby agree to the following:

- Management will sign off the rostering instruction/principles after consultation with organized Labour on a National Level, where there is no consensus Management will proceed with implementation, Labour will have recourse as contemplated in the LRA 66 of 1995.
- 2. Management will take into account the relevance of the Occupation Health and Safety act and the Code of Good Practice (BCEA), when compiling the rostering instructions/principals.
- 3. Shift patterns

Region departmental committees to be established to consult and build rosters/shits, these committees will consist of management and organized Labour.

- The New Rotational shift system will be implemented effective 1<sup>st</sup>
   September 2012, after regional consultations with effected employees on the new shift patens and new rosters, regional committees.
- National Labour together with Management will consult affected employees on the framework of the new rotational shift system.
